- ☐ CURFEW (7PM) and WORK FROM HOME REMAIN IN PLACE
- ☐ RESTRICTIVES MEASURES FOR SHOPS & BUSINESSES REMAIN UNCHANGED
- □ REOPENING OF JUNIOR AND SENIOR HIGH SCHOOLS WITH CAPACITY LIMITS
- ☐ END OF CERTIFICATE OF EXEMPTION WHEN TRAVELLING FURTHER THAN 10KM AND FOR INTERREGIONAL TRAVEL

- ☐ CURFEW (9 PM) and WORK FROM HOME REMAIN IN PLACE
- ☐ SHOPS & BUSINESSES CAN REEOPEN**
- □ REOPENING* OF CAFES AND RESTAURANTS, OUTDOOR ONLY, WITH A MAXIMUM OF 6 PER TABLE
- MUSEUMS, MONUMENTS, THEATERS, AUDITORIUM WITH SEATED AUDIENCE CAN REOPEN WITH 800 MAXIMUM CAPACITY INDOOR AND 1000 OUTDOOR
- □ REOPENING OF OUTDOOR SPORTS FACILITIES, INCLUDE THOSE COVERED FOR SPECTATORS WITH 800 MAXIMUM CAPACITY INDOOR AND 1000 OUTDOOR
- ☐ RESUMPTION OF SPORTS ACTIVITIES IN COVERED AND OUTDOOR FACILITIES WITH ADAPTED PROTOCOL
- ☐ GATHERING OF MORE THAN 10 PEOLE PROHIBITED

- □ REOPENING OF CAFES AND RESTAURANTS, INCLUDED INDOOR DINING, WITH A MAXIMUM OF 6 PER TABLE
- □ POSSIBILITY TO WELCOME UP TO 5000 PEOPLE IN CULTURAL AND SPORTS FACILITIES (subjected to health pass)
- ☐ REOPENING OF GYMS: CONTACT SPORT ONLY ALLOWED OUTDOOR
- REOPENING OF FAIRS AND EXHIBITIONS UP TO 5000 PEOPLE WITH HEALTH PASS (subjected to health pass)
- ☐ CURFEW AT 11 PM
- ☐ RECEPTION OF FOREIGN TOURISTS (subjected to health pass)

- □ ACCESS TO ANY PUBLIC EVENT WITH MORE THAN 1000 PEOPLE INDOORS AND OUTDOORS (subjected to health pass)*
- ☐ NIGHTS CLUBS REMAIN CLOSED
