# FRANCE TIMELINE FOR REOPENINGS : MAY 3<sup>rd</sup>

STEP 1\*

- ❑ CURFEW (7PM) and WORK FROM HOME REMAIN IN PLACE
- ❑ RESTRICTIVES MEASURES FOR SHOPS & BUSINESSES REMAIN UNCHANGED
- ❑ REOPENING OF JUNIOR AND SENIOR HIGH SCHOOLS WITH CAPACITY LIMITS
- ❑ NO RESTRICTIONS ON INTERREGIONAL TRAVEL

# FRANCE TIMELINE FOR REOPENINGS : MAY 19<sup>th</sup>

STEP 2 \*

- ❑ CURFEW (9 PM) and WORK FROM HOME REMAIN IN PLACE
- ❑ SHOPS & BUSINESSES CAN REOPEN\*\*
- ❑ REOPENING\* OF CAFES AND RESTAURANTS, OUTDOOR ONLY, WITH A MAXIMUM OF 6 PER TABLE
- ❑ MUSEUMS, MONUMENTS, THEATERS, AUDITORIUMS WITH SEATED AUDIENCE CAN REOPEN WITH A MAXIMUM CAPACITY OF 800 INDOOR AND 1000 OUTDOORS
- ❑ REOPENING OF OUTDOOR SPORTS FACILITIES, INCLUDING THOSE COVERED FOR SPECTATORS WITH A MAXIMUM CAPACITY OF 800 INDOOR AND 1000 OUTDOORS
- ❑ RESUMPTION OF SPORTS ACTIVITIES IN COVERED AND OUTDOOR FACILITIES WITH ADAPTED PROTOCOL
- ❑ GATHERING OF MORE THAN A GROUP OF 10 PEOPLE IN PUBLIC PLACES PROHIBITED

# FRANCE TIMELINE FOR REOPENINGS : JUNE 9<sup>th</sup>

STEP 3\*

- ❑ REOPENING OF CAFES AND RESTAURANTS, INCLUDING INDOOR DINING, WITH A MAXIMUM OF 6 PER TABLE
- ❑ POSSIBILITY TO RECEIVE UP TO 5000 PEOPLE IN CULTURAL AND SPORTS FACILITIES ( subject to health pass)
- ❑ REOPENING OF GYMS : ONLY CONTACT SPORT ALLOWED OUTDOORS
- ❑ REOPENING OF FAIRS AND EXHIBITIONS UP TO 5000 PEOPLE WITH HEALTH PASS ( subject to health pass)
- ❑ CURFEW MOVED TO 11 PM
- ❑ ARRIVAL OF OVERSEAS VISITORS (subject to health pass)

# FRANCE TIMELINE FOR REOPENINGS : JUNE 30<sup>th</sup>

STEP 4\*

- ❑ END OF CURFWEW
- ❑ NO MORE RESTRICTIONS ON CAPACITY LIMITS FOR ESTABLISHMENTS RECEIVING THE GENERAL PUBLIC- SOCIAL DISTANCING AND OTHER PROTECTIVE MEASURES REMAIN IN PLACE
- ❑ ACCESS TO ANY PUBLIC EVENT WITH MORE THAN 1000 PEOPLE INDOORS AND OUTDOORS ( subject to health pass)\*
- ❑ NIGHTS CLUBS REMAIN CLOSED

\*CAPACITY LIMIT SUBJECTED TO TYPE OF EVENT AND REGIONAL/LOCAL LEVEL OF VIRUS TRANSMISSION

\* UNLESS LOCAL/REGIONAL DETERIORATED SANITARY SITUATION \*\* VENUES REOPENING ARE CONDITIONNED TO IMPLEMENTATION AND RESPECT OF SANITAY PROTOCOL
